message from the president & executive director

We are very happy to be emerging from COVID this spring, and returning to some form of post-pandemic normality. Thanks to all of the hard work of our amazing staff, SHS maintained nearly full operations for the duration of the pandemic and had another very successful year.

2021 has begun with an expansion of the SHS team. In late 2020 Mark Baillie became SHS's Director of Operations, a role that is new to the Society and which will help position us for further growth. More recently we have added a new Assistant Property Manager position, bringing our staff to a total of 17 members. Saurabh Aggarwal joined the SHS team as the Assistant Property Manager in July 2021.

Throughout the past year we have also welcomed new staff members John Omuederiaye in the role of Property Manager and Jermaine Catua in the role of Janitor and temporary Building Management Assistant at MFA. Jun Manuel became Building Technician for MFA in January this year. It has been very gratifying to see staff members take on new challenges and responsibilities as the team grows.

Our District of North Vancouver project has reached another major milestone, with the submission of our Building Permit application in June 2021. We were very pleased that our project received unanimous support from the

DNV Council during the rezoning and development permit process, and we are eagerly awaiting the start of construction. We are optimistic that construction will begin by the end of this year, and the first tenants will be able to move in to their new homes during the fall of 2023.

Despite the vagaries of Zoom meetings, the SHS Board continues to be active and productive. A review of the Society's policies was completed over the past year, with updates to most policies and

the creation of a number of new policies to ensure that SHS continues to function well and consistently.

Board members are looking forward to the fall AGM, where we are optimistic that we can meet in-person for the first time in well over a year. This will be especially important, as this year the Board will say a fond thank you and farewell to Director Judy Lindsay, who will be leaving the Board after nearly 24 years. Judy's input to the Board and the Society has been invaluable, and her voice and wisdom will be very much missed.

Two Directors celebrated significant Board anniversaries in 2020 – Judy Newman had her 20th and Anthony Robinson his 15th. In March 2021 Lilly Woo reached her 15th Board anniversary, and later this year our President, Dane Jansen, will celebrate 30 years of Board service. With this incredibly dedicated group of talented and knowledgeable Directors, it is no wonder SHS is thriving!

treasurer's report

March 31, 2021 - Year End Report

I was pleased to step into the SHS Treasurer role this year, and look forward to continuing to work with Lilly Woo, who remains on the board.

It was a COVID year, unprecedented in our global history. Despite these challenges, SHS's dedicated team and partners continued to safely operate, fulfilling the needs of our current clients, and planning for the future to expand SHS's affordable housing options for those in need.

SAHS progressed further with the District of North Vancouver (DNV) affordable housing project, as pre-construction work continues. BC Housing has provided PDF funds to bring the project to construction readiness. We have submitted the Building Permit application and await approval to begin construction.

SHS has a strong balance sheet to support its goals. This year, the balance sheet was strengthened as the investment portfolio, that was negatively impacted last year due to COVID, experienced considerable recovery this year. SHS ended the year with slightly lower cash resources, reflecting its continued investment into its existing properties.

I am optimistic as we enter a post-COVID world, that SHS and its wonderfully dedicated team will continue to advance its mission. On behalf of the Board of Directors, our sincere gratitude for the team's passion, resilience and leadership in these uncertain times.

2020/21 was another busy year for the Property Management Team. There were several large projects completed at SHS properties, and we added new SPM client properties as well. SHS LICENSED CARE

Venture received a replacement of the main sewer line, all smoke detectors and a commercial gas stove.

Ford Apartments received approval from BCH for several major upgrades which we anticipate will begin in this upcoming 2021/22 fiscal year.


SANFORD PROPERTY MANAGEMENT
